

# PRIVACY POLICY

This privacy policy applies between you, the User of this Website and MyTenantRent.co.uk LTD, the owner and provider of this Website. MyTenantRent.co.uk LTD takes the privacy of your information very seriously. This privacy policy applies to our use of any and all Data collected by us or provided by you in relation to your use of the Website.

**Please read this privacy policy carefully.**

## Definitions and interpretation

1. In this privacy policy, the following definitions are used:

<b>Data</b>	collectively all information that you submit to MyTenantRent.co.uk LTD via the Website. This definition incorporates, where applicable, the definitions provided in the Data Protection Laws;
<b>Cookies</b>	a small text file placed on your computer by this Website when you visit certain parts of the Website and/or when you use certain features of the Website. Details of the cookies used by this Website are set out in the clause below ( <b>Cookies</b> );
<b>Data Protection Laws</b>	any applicable law relating to the processing of personal Data, including but not limited to the Directive 96/46/EC (Data Protection Directive) or the GDPR, and any national implementing laws, regulations and secondary legislation, for as long as the GDPR is effective in the UK;
<b>GDPR</b>	the General Data Protection Regulation (EU) 2016/679;
<b>MyTenantRent.co.uk LTD, we or us</b>	MyTenantRent.co.uk LTD, a company incorporated in England and Wales with registered number 10485581 whose registered office is at 95 Holt Road, Liverpool, L7 2PN;
<b>UK and EU Cookie Law</b>	the Privacy and Electronic Communications (EC Directive) Regulations 2003 as amended by the Privacy and Electronic Communications (EC Directive) (Amendment) Regulations 2011;
<b>User or you</b>	any third party that accesses the Website and is not either (i) employed by MyTenantRent.co.uk LTD and acting in the course of their employment or (ii) engaged as a consultant or otherwise providing services to MyTenantRent.co.uk LTD and accessing the Website in connection with the provision of such services; and

2. In this privacy policy, unless the context requires a different interpretation:
  - a. the singular includes the plural and vice versa;
  - b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
  - c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
  - d. "including" is understood to mean "including without limitation";
  - e. reference to any statutory provision includes any modification or amendment of it;
  - f. the headings and sub-headings do not form part of this privacy policy.

## Scope of this privacy policy

3. This privacy policy applies only to the actions of MyTenantRent.co.uk LTD and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.

4. For purposes of the applicable Data Protection Laws, MyTenantRent.co.uk LTD is the "data controller". This means that MyTenantRent.co.uk LTD determines the purposes for which, and the manner in which, your Data is processed.

## **Data collected**

in each case, in accordance with this privacy policy.

## **How we collect Data**

6. We collect Data in the following ways:
  - a. data is given to us by you ;
  - b. data is received from other sources; and
  - c. data is collected automatically.

## **Data that is given to us by you**

7. MyTenantRent.co.uk LTD will collect your Data in a number of ways, for example:
  - a. when you contact us through the Website, by telephone, post, e-mail or through any other means;
  - b. when you make payments to us, through this Website or otherwise;
  - c. when you elect to receive marketing communications from us;
  - d. when you use our services;
  - e. Debt Collection Agencies;
  - f. Employers;
  - g. Credit Referencing Companies;
  - h. ;

in each case, in accordance with this privacy policy.

## **Data that is received from third parties**

8. MyTenantRent.co.uk LTD will receive Data about you from the following third parties:

- a. Credit Reference Agencies;
- b. Employers;
- c. Current and/or Previous Landlords;

## **Data that is collected automatically**

9. To the extent that you access the Website, we will collect your Data automatically, for example:
  - a. we automatically collect some information about your visit to the Website. This information helps us to make improvements to Website content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.
  - b. we will collect your Data automatically via cookies, in line with the cookie settings on your browser. For more information about cookies, and how we use them on the Website, see the section below, headed "Cookies".

## **Our use of Data**

10. Any or all of the above Data may be required by us from time to time in order to provide you with the best possible service and experience when using our Website. Specifically, Data may be used by us for the following reasons:
  - a. internal record keeping;
  - b. transmission by email of marketing materials that may be of interest to you;in each case, in accordance with this privacy policy.
11. We may use your Data for the above purposes if we deem it necessary to do so for our legitimate interests. If you are not satisfied with this, you have the right to object in certain circumstances (see the section headed "Your rights" below).
12. For the delivery of direct marketing to you via e-mail, we'll need your consent, whether via an opt-in or soft-opt-in:

in each case, in accordance with this privacy policy.

## Keeping Data secure

14. We will use technical and organisational measures to safeguard your Data, for example:
  - a. access to your account is controlled by a password and a user name that is unique to you.
  - b. we store your Data on secure servers.
  - c. payment details are encrypted using SSL technology (typically you will see a lock icon or green address bar (or both) in your browser when we use this technology.
15. We are certified to PCI DSS. This family of standards helps us manage your Data and keep it secure.
16. Technical and organisational measures include measures to deal with any suspected data breach. ## Data retention

18. Unless a longer retention period is required or permitted by law, we will only hold your Data on our systems for the period necessary to fulfil the purposes outlined in this privacy policy or until you request that the Data be deleted.
19. Even if we delete your Data, it may persist on backup or archival media for legal, tax or regulatory purposes.

## Your rights

20. You have the following rights in relation to your Data:
  - a. **Right to access** - the right to request (i) copies of the information we hold about you at any time, or (ii) that we modify, update or delete such information. If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive." Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.
  - b. **Right to correct** - the right to have your Data rectified if it is inaccurate or incomplete.
  - c. **Right to erase** - the right to request that we delete or remove your Data from our systems.
  - d. **Right to restrict our use of your Data** - the right to "block" us from using your Data or limit the way in which we can use it.
  - e. **Right to data portability** - the right to request that we move, copy or transfer your Data.
  - f. **Right to object** - the right to object to our use of your Data including where we use it for our legitimate interests.

## Changes of business ownership and control

Data provided by Users will, where it is relevant to any part of our business so transferred, be transferred along with that part and the new owner or newly controlling party will, under the terms of this privacy policy, be permitted to use the Data for the purposes for which it was originally supplied to us.
26. We may also disclose Data to a prospective purchaser of our business or any part of it.
27. In the above instances, we will take steps with the aim of ensuring your privacy is protected.

## MyTenantRent GDPR1 Document

All data is collecting for the sole purpose of administering the tenancy, performing maintenance on the property and fulfilling our legal obligations in line with UK Law.

We do not collect any information for the sole purpose of marketing, nor do we sell any data to any third party whatsoever.

### ***Part 1 - Who do we share information with and what information do we share?***

Your Landlord – we will make your landlord aware of **any** information that could affect their decision to offer you a tenancy in one of their properties.

Deposit Protection Scheme – we will share **any** information relating to the tenancy which could affect the deposit or any deposit deductions.

Liverpool City Council – we always inform the Council when a new tenant has moved in to ensure their council tax information is correct and up-to-date.

Emergency Services – In the event of an emergency, fire or incident of crime at the property, we may pass personal information to the Police, Ambulance Service or Fire Service to help with any emergency or ongoing investigation.

HM Courts and Tribunals Service – As above, in the event of a crime or any legal action, we may pass **any** information to the UK Courts to administer the case and assist with any requests for information.

We will provide HM Courts Service with **any** details pertaining to the tenancy that are relevant to any particular case.



Solicitors & Potential new owners of the property – In the event that the interest in the property changes, tenancy documentation will be provided to any potential new owner and their solicitor in order to administer the sale of the property. This involves ASTs and rental statements, and **any** other information relating to the tenancy which will include tenant names and tenancy information.

Guarantors – We may pass on **any** information relating to the tenancy that could incur costs to the guarantor e.g. rent arrears, damage to the property, anti-social behaviour. We may share your contact details with other guarantors in order to effectively administer the tenancy.

The Deposit Protection Service – We may pass on **any** information relating to the tenancy required to administer the protection of the deposit/deposit returns, as well as the arbitration service.

Lettings Management – We will use your name, email and phone number to administer the tenancy, including sending you important information during the tenancy, as well as pre-tenancy documents and post-tenancy documents.
